Please note: Customers who reside in a copper-fed area must have a modem to access the Internet. Customers can choose to lease the modem for \$5 per month or purchase a modem for \$95. A customer service representative will help you determine if you are in a copper-fed service area. Customers who reside in a fiber-optic area will be offered enhanced fiber-optic speed (double upload) for \$5 per month.

In addition to completing the application on page 3, you must choose to join the educator's discount Facebook Group or email distribution list. This will allow SkyLine/SkyBest to track your eligibility for the program each year without requiring that you complete new applications annually.

FOUR SIMPLE STEPS TO JOIN THE EDUCATOR'S DISCOUNT FACEBOOK GROUP

Step Four: A SkyLine/SkyBest representative will add you to a group specifically designed for your county. You will receive a notification when you have been added to the group. Please do not remove yourself from the group or your educator's discount will be cancelled.
